

Explanation

- The India-Bangladesh border spans approximately 4,096 km, making it the **longest** international border that India shares with any country.
- Of this total, West Bengal's share is about 2,217 km, which is the longest stretch compared to other Indian states that also border Bangladesh.
- Bangladesh shares borders with five Indian states: Assam, West Bengal, Mizoram, Meghalaya, and Tripura.

Explanation

- Kursk Oblast has been in the news due to its strategic location near the Russia-Ukraine border.
- Kursk Oblast is a region in Russia that shares its western border with Ukraine.
- It lies in the southwestern part of Russia, with the city of Kursk as its administrative center.

3. Answer: D

Explanation

- The Multilateral Convention to Implement Tax Treaty Related Measures to Prevent Base Erosion and Profit Shifting is an **outcome of the OECD** to tackle Base Erosion and Profit Shifting (the **"BEPS Project"**).
- BEPS is a **tax planning strategy** that exploit gaps and mismatches in tax rules to artificially shift profits to low or no-tax locations where there is little or no economic activity, resulting in little or no overall corporate tax being paid.

4. Answer: C

Explanation

- In 2014, the government launched Pradhan Mantri Jan Dhan Yojana (PMJDY) to bring about **comprehensive financial inclusion** in the country.
- PMJDY envisages universal access to banking facilities with **at least one basic banking account for 'every adult', financial literacy, access to credit, insurance and pension** facility.

Features

- Under the scheme, a **basic savings bank deposit (BSBD) account** can be opened by persons not having any other account.
- There is **no requirement to maintain any minimum balance** in PMJDY accounts.
- **Interest** is earned on the deposit in PMJDY accounts.
- **Rupay Debit card** is provided to PMJDY account holders.
- Accident Insurance Cover of Rs.2 lakh is available with RuPay card issued to the PMJDY account holders.
- An overdraft (OD) facility up to Rs. 10,000 to eligible account holders is available.

• PMJDY accounts are eligible for Direct Benefit Transfer (DBT), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Atal Pension Yojana (APY), Micro Units Development & Refinance Agency Bank (MUDRA) scheme.

- **State Election Commission (SEC)** is responsible for the superintendence, direction, and control of the preparation of electoral rolls and the conduct of elections to Panchayats and urban local bodies.
- This responsibility is enshrined in the Constitution of India under the 73rd and 74th Amendments, which provide for the establishment of the State Election Commission in each state.
