1. Answer: B

Explanation

- Stand up India Scheme was launched in 2016 to promote entrepreneurship at grassroot level focusing on economic empowerment and job creation.
- **Statement 1 is correct:** The purpose of Stand-Up India is to promote entrepreneurship amongst **women**, **SC & ST category**.
- Statement 2 is correct: Loans under the scheme are available for only green field projects. Green field signifies, in this context, the first-time venture of the beneficiary in the manufacturing, services or the trading sector & activities allied to agriculture.
- **Statement 3 is incorrect:** The scheme is anchored by the **Department of Financial Services (DFS), Ministry of Finance.**

2. Answer: B

Explanation

In **2015**, the Parliamentary Standing Committee on Personnel, Public Grievances, Law and Justice, headed by E M Sudarsana Natchiappan, prepared a report on holding simultaneous elections. The report said that simultaneous elections would help to reduce:

- the massive expenditure that is currently incurred for the conduct of separate elections,
- the policy paralysis that results from the imposition of the Model Code of Conduct during election time,
- the impact on the delivery of essential services and,
- the burden on crucial manpower that is deployed during election time.

• Curative petitions is a judicially created mechanism of the Court to ensure that an aggrieved person is entitled to relief against the final judgment of the Court after the dismissal of a review petition, in order to do complete justice as intended under Article 142 of the Constitution of India.

- The statutory provisions for **Review Petition** is under **Article 136** of the Constitution from an **order of the High Court refusing to grant a certificate under Article 134A** of the Constitution or in any other case from any judgment, decree, determination, sentence, or order passed or made by any Court or Tribunal, except relating to armed forces.
- Writ petitions are filed in the Supreme Court and High Courts of India. The statutory provisions for such Petitions are in Article 32 and 226 of the Constitution to file in the Supreme Court and High Courts, respectively. The Court may issue writs like habeas corpus, mandamus, certiorari, quo warranto, and prohibition.
- The **review petition** is a petition in which it is prayed before the Court of law to review its order or judgement which it has already pronounced. Under Article 137 of the Constitution of India and the rules made under Article 145, the Supreme Court of India has the power to review its judgment pronounced by it.

4. Answer: A

Explanation

- **Operation Flood**, also referred to as the **"White Revolution,"** was a **massive dairy development program** launched by the Indian government in **1970**.
- It transformed India from a milk-deficient nation to a milk-surplus one.

5. Answer: A

Explanation

- India and the United Arab Emirates (UAE)' Comprehensive Economic Partnership Agreement (CEPA) entered into force in 2022.
- The bilateral trade pact is **India's first in the region and the first comprehensive trade agreement with any country in a decade. Hence statement 1 is correct.**
- This landmark agreement has set out the **bilateral trade target of US\$100 billion**, to be achieved in the next five years.

Features of CEPA

- CEPA covers goods, services and digital trade, among others, that allows 90% of India's exports a duty-free access to the Emirates. Hence statement 2 is incorrect.
- Besides trade in goods, under CEPA, the **services sector** comprising computer-related services, health, tourism, travel, engineering, and accountancy also get **preferential market** access to the UAE economy.
- The agreement also provides for
 - An **open and non-discriminatory environment for cross-border trade** between the two countries;
 - The **removal of unnecessary technical barriers (TBT)** for UAE and Indian exporters.
- India has **excluded certain goods** (such as Dairy, fruits, vegetables, cereals, tea, coffee, sugar, etc.) from the agreement through a **"sensitive list" of products** amounting to 10 per cent of tariff lines that are excluded completely from the agreement.

- The agreement contains **strict rules of origin provisions** to prevent other countries from using the agreement to reroute their exports through UAE to benefit from lower tariffs.
- The agreement also has **safeguard mechanisms** that would be triggered if there was a significant surge in imports of a specific product in either country.
