

- Considered to be one of the many great social reformers, Basavanna stood for the underprivileged classes and women's rights.
- He spread social awareness through his poetry called **Vachanaas**. Hence, **the answer is option D.**

2. Answer: D

Explanation

- The Indian Council for Cultural Relations (ICCR) was founded in **1950** by **Maulana Abul Kalam Azad**, independent India's first Education Minister. Hence, **statement 1** is **correct**.
- Its objectives are to:
 - o actively participate in the formulation and implementation of policies and programmes pertaining to **India's external cultural relations**; Hence, **statement 2** is correct.
 - to **foster and strengthen cultural relations and mutual understanding** between India and other countries;
 - to promote **cultural exchanges** with other countries and people, and
 - to develop relations with nations.
- The Council addresses its **mandate of cultural diplomacy** through a broad range of activities. Hence, **statement 3 is correct.**

- In addition to organising cultural festivals in India and overseas, the ICCR financially supports a number of cultural institutions across India, and sponsors individual performers in dance, music, photography, theatre, and the visual arts.
- The ICCR Headquarter is situated in **New Delhi**.

3. Answer: A

Explanation

- The UN Statistical Commission, established in 1947, is the highest body of the global statistical system bringing together the Chief Statisticians from member states from around the world. Hence, statement 1 is correct.
- It is the **highest decision-making body for international statistical activities**, responsible for setting statistical standards and the development of concepts and methods, including their implementation at the national and international levels.
- The Commission consists of **24 member countries** of the United Nations elected by the **United Nations Economic and Social Council (ECOSOC)** on the **basis of equitable geographical distribution.** Hence, **statement 2 is incorrect.**

4. Answer: A

Explanation

- A rating agency is a company that assesses the financial strength of companies and government entities, especially their ability to meet principal and interest payments on their debts. Hence, statement 1 is correct.
- The rating shows an agency's level of confidence that the borrower will honor its debt obligations as agreed. Each agency uses **unique letter-based scores** to indicate if a debt has a low or high default risk and the financial stability of its issuer.
- The debt issuers may be sovereign nations, local and state governments, special purpose institutions, companies, or non-profit organizations.
- In India, the **Securities and Exchange Board of India (SEBI)** primarily regulates credit rating agencies and their functioning. Hence, **statement 2 is incorrect.**

5. Answer: B

• Sulphur dioxide (SO2) is a **gaseous air pollutant composed of sulfur and oxygen.**

- SO2 is a **colourless**, **soluble gas** with a **characteristic pungent smell** which forms sulphuric acid when combined with water. Hence, **statement 1** is **incorrect and statement 2** is **correct**.
- SO2 emissions can cause **respiratory**, **cardiovascular and lung diseases**, and can **induce acid rain**, which is a threat to crops, forests, and aquatic species. Hence, **statement 3 is correct**.
