1. Answer: A

### **Explanation:**

• **Shayara Bano v. Union of India** (2017), wherein the Supreme Court declared the practice of **instant triple talaq** (talaq-e-biddah) **unconstitutional**, affirming that it violates the fundamental rights of Muslim women and is against the principles of gender justice. **Hence answer is option A**.

2. Answer: A

#### **Explanation:**

- The National Disaster Management Authority (NDMA) is a statutory body constituted under the Disaster Management Act 2005, with the Prime Minister of India as its Chairman, a Vice Chairman with the status of Cabinet Minister, and eight members with the status of Ministers of State. Hence statement 1 is incorrect and statement 2 is correct.
- The Disaster Management Act also has statutory provisions for the constitution of the National Disaster Response Force for the purpose of specialized response to natural and man-made disasters.

• The NDMA is the apex statutory body for disaster management in India. It is under the control of the Ministry of Home Affairs (MHA). Hence statement 3 is incorrect.

#### 3. Answer: B

### **Explanation:**

- The Centre has done away with the "no-detention" policy for Classes 5 and 8, paving the way for schools to fail students who are unable to clear year-end exams.
- The Ministry of Education has published a gazette notification, titled "Right of Children to Free and Compulsory Education (Amendment) Rules, 2024", which states that if a child fails to fulfil promotion criteria in Classes 5 or 8 in the regular examination, they can be held back. Hence statement 2 is correct.
- In the Rules, the Ministry also emphasised the need for **remedial measures** for such students to close learning gaps. **Hence statement 3 is correct.**
- While the **Right to Education Act, 2009** had been amended to scrap the no-detention policy as early as 2019, the Rules have been notified only now.
- After all other options are exhausted, if there is a need to detain the student, they shall be
  detained. At the same time, no student should be expelled from school until Class 8. Hence
  statement 1 is incorrect.
- The 'no-detention' policy was **enshrined** in the Right to Education Act, 2009, but one of the significant concerns was that the policy led to high failure rates.

#### 4. Answer: A

#### **Explanation:**

- The Order stated that no foreigner shall enter into or remain in any protected area except under and in accordance with a permit issued by the Central government or any office authorised by the Central government. Hence statement 1 is correct and statement 2 is incorrect.
- The permit shall include the following details place of entry, place of residence and period of stay. Hence statement 3 is incorrect.
- The areas falling between the inner line and the international Border of the following States and Union Territories were declared as Protected Areas parts of Himachal Pradesh and Jammu and Kashmir, Ladakh, Rajasthan and Uttarakhand and the whole of Manipur, Mizoram, Nagaland, and Sikkim (partly as protected areas and partly as restricted areas).
- Another Order in 1963 declared the entire Andaman & Nicobar Islands and parts of Sikkim as "restricted area."

## **Explanation:**

- The **General Agreement on Tariffs and Trade (GATT)**, signed in **1947**, is a treaty **minimizing barriers to international trade** by eliminating or reducing quotas, tariffs, and subsidies. It was intended to **boost economic recovery after World War II. Hence statement 1 is correct.**
- GATT was expanded and refined over the years, leading to the creation in **1995** of the **World Trade Organization**, which absorbed the organization created to implement GATT. **Hence statement 2 is incorrect.**
- The **Council for Trade in Goods (Goods Council)** is now responsible for the GATT and consists of representatives from all WTO member countries.
